We are writing to you on behalf of our subscribers who live, work and vote in your constituency. We would like to introduce you to an issue which is of immediate concern to them and to over 90,000* of their fellow citizens across the country.

You will find full details of the information enclosed on the overleaf.

We are the Natural Health Products Protection Association. Our subscribers are outraged that their government is handing their constitutional right to control their own health and that of their families to unelected officials. We all consider that, as the elected federal representative for these constituents, their ongoing well-being is your concern.

We ask you to address these concerns as a matter of urgency and to act to protect Canadians' constitutional right to consume the Natural Health Product (NHP) of their choice. Health Canada has repeatedly stated that the current regulatory climate for NHPs is for our safety, however there is zero evidence of harm from the choices of Canadians to consume these products...and an alarming body of evidence growing for the harm being done to Canadians by the ever-increasing restrictions.

We are horrified that our elected government has chosen to ignore evidence of harm, to allow Health Canada to ignore evidence of harm, and to stand by while all our constitutional rights are removed.

Thousands of NHPs have been removed from the Canadian market since 2004, despite zero evidence of any harm from any product. (And zero deaths, since Canadian records began.) As our subscribers' representative in Ottawa, we expect you to refrain from accepting disingenuous platitudes from unelected bureaucrats at Health Canada's Natural Health Products Directorate (and their 'advisors' with documented divided loyalties) to and investigate this matter for yourself.

Thank you in advance for your consideration and your written response to the above.

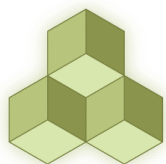
