

**THERE IS NO MIDDLE GROUND:  
WHICH SIDE ARE YOU ON?**

**Your Actions Either Support Or Resist  
The Canadian Police State**

## November 11, 2021

I felt compelled to start writing this on Remembrance Day.

November 11 is the time for us to give thanks to those who fought to preserve our freedoms. We pay homage to those who were wounded or killed to protect the freedoms that were fundamental to our way of life. The fight for freedom was particularly clear in the Second World War. For much of the war a police state was imposed on most of Europe.

**Unimaginable affronts to human dignity and freedom were imposed** such as requiring papers for the freedom of movement and for access to services. Undesirable groups were defined and created to divide the populace, to instill fear, and to ultimately kill.

So, it is both apposite and ironic that we are celebrating Remembrance Day in the very type of police state that our veterans fought and died to protect us from.

In Canada, in 2021, **unimaginable affronts to human dignity and freedom have been imposed** such as requiring papers for the freedom of movement and for access to services. An undesirable group, the “unvaccinated”, has been defined and created to divide the populace, instill fear, and, as with all police states, to ultimately kill.

## The Loss Of Our Freedoms

The loss of our freedoms has come as a shock to those who do not study history.

In the last century, more people have been killed by their own governments than by wars. Any person who would trust their government with their lives is likely under a spell.

As a lawyer who has spent almost three decades fighting for our rights in Court, I have been inundated with calls since our governments started imposing vaccine mandates. Many have been from people who were going to lose their jobs if they did not submit to the vaccine. I shared with them my opinion that the mandates are illegal, but that I did not expect the Queen’s Courts to protect us from the Queen’s Governments.

For almost two years I have witnessed a shocking disregard for our fundamental rights and freedoms—all accepted and supported by a populace hypnotized by the siren song of fear.

In that context I did not believe the Courts would make a meaningful difference. And they haven’t.

## Our Charter Rights

I could not have agreed with Bruce Pardy more when he wrote in the Financial Post on November 3, 2021, that:

“Ten days ago the Manitoba Court of Queen’s Bench was the latest court to rebuff a constitutional challenge to COVID restrictions on civil liberties.

Chief Justice Glenn Joyal ruled that provincial public health orders were constitutionally justifiable, joining courts from around the country in embracing the official COVID narrative and defending the authority of the pandemic state.

Over the past 20 months, lockdowns, masking rules, traveller quarantines, closed borders, business restrictions and now vaccine mandates have made Canadians less free than they have ever been.

Yet so far charter challenges to COVID rules have been spectacularly unsuccessful. During COVID, the charter has been useless.”

The “charter” Mr. Pardy is referring to is the *Canadian Charter of Rights and Freedoms* which forms part of Canada’s Constitution and which most believed contained fundamental rights which governments had to respect.

At least that myth has been dispelled.

## **Rights & Freedoms**

For the hundreds of millions murdered by their own governments in the last century, none found salvation in the Courts. For the hundreds of millions more who lived as slaves in police states, none found freedom in the Courts.

Paper is paper. You do not have rights or freedoms because of writing on paper. Courts are Courts. You do not have rights or freedoms because you ask a Government Court for them.

**You only truly have a right or a freedom if you are willing to fight for it.** Freedom only exists if a people demands and fights for it.

The former slave Frederick Douglass made this clear when he wrote:

“Power concedes nothing without a demand. It never did and it never will. Find out just what any people will quietly submit to and you have found out the exact measure of injustice and wrong which will be imposed upon them.”

## **Quiet Submission**

We are quickly finding out what Canadians will quietly submit to.

- Canadians will quietly submit to being imprisoned in their homes without even the right to apply for parole.
- Canadians will quietly submit to their livelihoods being destroyed.

- Canadians will quietly submit to needing identification papers to travel or to access services.
- Canadians will quietly submit to a sub-class of citizens being created and vilified to keep us divided and in fear.
- Canadians will quietly submit to being fed a single narrative which leads them to participate in ridiculing and shutting down other points of view which do not agree with the “official narrative”.

As our governments keep pushing us farther to see how much we will quietly submit to, it is still left to be determined whether we will quietly submit to:

- the “unvaccinated” being confined to their homes like criminals;
- the “unvaccinated” being denied more services;
- the “unvaccinated” being segregated into camps;
- the “unvaccinated” dying in the camps;
- forced vaccination as part of on-going new vaccination requirements;
- our property being taken.

As of today, I would not be surprised if most—if not all—of the above is allowed to happen because Canadians quietly submit to it.

## **Shocked & Disappointed**

I am shocked and disappointed in myself, and in my fellow Canadians.

The contrast between our resolve during the Second World War and today is glaring. During the Second World War Canadians mobilized, fought and died to preserve our freedoms.

I am reminded of Winston Churchill’s speech on June 18, 1940, a dark hour when the fate of the Common Wealth looked bleak. After outlining the recent military disasters Churchill said:

“What General Weygand called the Battle of France is over. I expect that the Battle of Britain is about to begin. Upon this battle depends the survival of Christian Civilization. Upon it depends our own British life, and the long continuity of our institutions and our Empire. The whole fury and might of the enemy must very soon be turned on us.

Hitler knows that he will have to break us in this Island or lose the war. If we can stand up to him, all Europe may be free, and the life of the world may move forward

into broad, sunlit uplands. But if we fail, then the whole world, including the United States, including all that we have known and cared for, will sink into the abyss of a new Dark Age made more sinister, and perhaps more protracted, by the lights of perverted science.

Let us therefore brace ourselves to our duties, and so bear ourselves that if the British Empire and its commonwealth last for a thousand years, men will still say, 'This was their finest hour'."

Over the next thousand years people may look back at the Common Wealth during the Second World War and say, "This was their finest hour". Contrast that with the actions of Canadians today, and future generations will most likely conclude: "This was their worst hour."

## **Our Worst Hour**

This is our worst hour because we have been so hypnotized by fear that we do not understand that our actions are supporting the police state.

Every person who accesses a service denied to sub-citizens is supporting the police state. Businesses would not be enforcing ID paper requirements if it meant they had no customers.

Every person who wears a mask believing it makes no difference, or actually aggravates health, supports the police state.

Every person who reports their neighbour like KGB or Stasi snitches supports the police state.

## **Our Decision To Make**

It does not matter where you stand on the pandemic, or vaccines, or what you think the best health measures are.

**This is about choosing whether we will face those issues as free citizens in a free country or whether we will face those issues as slaves in a police state.**

And when we couch it in those terms, the question begging to be asked is: would you rather pull together and tackle challenges like pandemics or vaccines as a free citizen in a free country or would you rather tackle those challenges as a slave in a police state?

Which is likely to have better outcomes?

## **Every Choice Matters**

Your actions are not without consequences.

If your actions support and perpetuate our loss of freedoms by submitting to them, you are actively supporting the police state.

You need to break the spell and understand that history is now and is calling on you to make this your finest hour.

**You do not have as much time as you think.**

On Remembrance Day, let us pay attention to the common *warning* on memorials to our war dead:

“Lest We Forget.”
